GENERAL INFORMATION

CNI Hu-Man™ Liquid Manganese is a liquid plant food containing Humic Acid and Manganese along with Nitrogen and Sulfur specifically formulated to achieve compatibility with glyphosate and other selective and non-selective herbicides commonly tank-mixed with ammonium sulfate or other fertilizer salts. A proprietary blend of compatibility and chelating agents preserves the efficacy of the herbicides while maintaining the availability of the manganese. **CNI Hu-Man™ Liquid Manganese** is recommended for foliar application on soybeans, peanuts, cotton and most other crops that require manganese. Manganese is essential for carbohydrate and nitrogen metabolism and in chlorophyll production. It accelerates germination and maturity.

DIRECTIONS FOR USE

CNI Hu-Man™ Liquid Manganese is to be tank-mixed in a prescribed sequence as follows: 1. water, 2. ammonium sulfate, 3. this product, and 4. glyphosate or other herbicide.

RECOMMENDED RATES

Apply at the rate of 1-2 qts/acre in 10-20 gallons of water. Manganese does not translocate to new growth. Accordingly, a second application maybe necessary.

WHAT TO DO IN CASE OF CONTACT

If Ingested: Give large amounts of water or milk, if conscious. Contact a physician immediately.

Eye Contact: Flush eyes with clean water for 15 minutes. Seek medical attention immediately.

Skin Contact: Remove contaminated clothing and wash skin with soap and water. Seek medical attention if irritation develops or persists.

If Inhaled: Move to fresh air and seek medical attention if irritation develops or persists.
