GENERAL INFORMATION

HARVESTER 15-2-3 is powered by a patented combination of amino acids and proteins which activate several beneficial biological and environmental responses in plants. This proprietary nutritional technology increases yield potential, improves growth, plant health and quality.

HARVESTER 15-2-3 is non-phytotoxic and can be applied foliar to most crops. It is recommended for use throughout the season in a program of multiple applications.

DIRECTIONS FOR USE

HARVESTER 15-2-3 is designed for foliar, soil, and chemigation application. Apply by a spray method and in an adequate amount of water that will provide complete coverage of the plants.

HARVESTER 15-2-3 will disperse in water with minimal agitation. The rate of application will depend on the crop, stage of growth, and severity of deficiency. For best results apply according to recommendations based on plant tissue or soil analysis. Follow the mixing sequence: 1. Water; 2 HARVESTER 15-2-3; 3. Pesticide.

SHAKE WELL BEFORE USE

GENERAL RECOMMENDATIONS

Golf Course Greens: Apply 3.0 to 6.0 fl oz per 1000 sq ft in enough water to provide sufficient foliar coverage. Repeat application every 7 to 14 days. Warm season turf may require more frequent applications.

Golf Course Tees and Fairways: Apply 3.0 to 12.0 fl oz per 1000 sq ft in a minimum of 1.0 gal spray solution per 1000 sq ft. Repeat application every 14 to 28 days.

Commercial and Residential Lawns, Athletic Fields: Apply at 2 to 5 gals per acre in a minimum of 88 gal per acre of spray solution. Repeat application every 3 to 6 weeks. Use the lower rates if daytime temperature exceed 85 degrees or if turf is exhibiting symptoms of drought stress.

WHAT TO DO IN CASE OF CONTACT

If Ingested:	Give large amounts of water or milk, if conscious. Contact a physician immediately.
Eye Contact:	Flush eyes with clean water for 15 minutes. Seek medical attention immediately.
