Dissolve 5 lbs. per 100 gallons of water and apply as spray. 5 lbs. covers one acre. For best results, repeat every 2 weeks, taking soil and weather conditions into consideration. Concentrate fluid should not exceed 10 lbs. in 10 gallons of water. For Transplanting, dissolve 5 lbs. per 100 gallons of water. However, these rates may or may not meet the grower's requirements.
