GENERAL INFORMATION

HARVESTER Oasis is powered by a patented combination of amino acids, humic acids, and proteins which activate several beneficial biological and environmental responses in plants. This proprietary nutritional technology increases yield potential, improves growth, plant health and quality.

HARVESTER Oasis is non-phytotoxic and can be applied foliar to most crops. It is recommended for use throughout the season in a program of multiple applications.

DIRECTIONS FOR USE

HARVESTER Oasis is designed for foliar, soil, and chemigation application. Apply by a spray method and in an adequate amount of water that will provide complete coverage of the plants. **CAUTION: DO NOT USE IN HIGH PHOSPHATE "STARTER" OR "POP-UP" FERTILIZER MATERIALS SUCH AS 10-34-0.**

HARVESTER Oasis will disperse in water with minimal agitation. The rate of application will depend on the crop, stage of growth, and severity of deficiency. For best results apply according to recommendations based on plant tissue or soil analysis. Follow the mixing sequence: 1. Water 2. **HARVESTER Oasis** 3. Pesticide.

GENERAL RECOMMENDATIONS

Fruit, Vegetables, and Row Crops: Make 2-3 applications of 2 quarts per acre.

Citrus: Make 2-4 applications of 2 quarts per acre.

WHAT TO DO IN CASE OF CONTACT

If Ingested: Give large amounts of water or milk, if conscious. Contact a physician immediately.
