### GENERAL INFORMATION

**CHEM-KEY™ LIQUID ZINC** is a complexed liquid micronutrient compound containing sulfur and zinc. It is designed for foliar and soil application for prevention and correction of zinc deficiency. It is recommended for use as an additive in liquid or dry fertilizers. It is compatible with most agricultural pesticides.

**CHEM-KEY™ LIQUID ZINC** tank-mixed in water will decrease alkaline hydrolysis associated with organo-phosphate pesticides.

**CHEM-KEY™ LIQUID ZINC** is NOT RECOMMENDED for use with pesticides that are not compatible with acid materials. DO NOT MIX WITH HIGH PHOSPHATE LIQUID FERTILIZERS.

### DIRECTIONS FOR USE

**CHEM-KEY™ LIQUID ZINC** may be applied by ground or aerial application. Use sufficient water for thorough and uniform coverage of foliage or soil. Foliar application is recommended when fast correction is desired. For best results use a non-ionic surfactant.

**Mixing Instructions:** Always check compatibility before mixing. Use only the following sequence: 1. Water, 2. **CHEM-KEY™ LIQUID ZINC**, 3. Pesticides or fertilizers.

### RECOMMENDED RATES

Rates and timing of application are dependent on local conditions and should always be made as a result of soil and/or plant tissue analysis. Local climatic conditions, infestations and other factors affect the performance of any pesticide or nutritional spray. Therefore, consult your local chemical company representative or agricultural extension agent for specific use information in your area.

### WHAT TO DO IN CASE OF CONTACT

<b>If Ingested:</b>	Give large amounts of water or milk, if conscious. Contact a physician immediately.
<b>Eye Contact:</b>	Flush eyes with clean water for 15 minutes. Seek medical attention immediately.
<b>Skin Contact:</b>	Remove contaminated clothing and wash skin with soap and water. Seek medical attention if irritation develops or persists.
<b>If Inhaled:</b>	Move to fresh air and seek medical attention if irritation develops or persists.
